- (1) The following applications were acted upon:

The AERC agreed it would not seek the comments of neighbors nor consider code/zoning issues when considering the approval of an application
- (5) To attract new members, the AERC will develop a flyer. Betsy will develop the flyer. Bernie will provide some draft wording for Betsy. Carol asked that we incorporate the Board's opinion on the wording of the flyer.

- (2) In the event that a property with a violation, makes an application for a change, the decision for such change will be referred to the Board.
